# Guidelines for Anonymizing NBDR Data Elements

Version 1.1 April 2022



# Guidelines for Anonymizing an NBDR Data Extract

This document specifies the data elements in the Nominee Broker Data Requirements ("NBDR") which a Nominee Broker ("NB") is required to "mask" should CDIC request a de-identified data extract. A de-identified data extract should be submitted to CDIC through the established process as set out in the NBDR, or as otherwise instructed by CDIC.

#### **Masking NBDR Data**

Where an NB receives a request from CDIC to provide a de-identified data extract, the NB must be capable of masking certain data elements (fields).

#### To mask data:

- The values of the masked field must be replaced with anonymous values, not related or connected to the values it replaced;
- The masking value should comply with the Field Format requirements;
- Option #1: the masked value does not have to be unique but the masked value should have the same character string length as the original unmasked value (e.g., "CDIC" can be masked as "U59J" in one instance and "3FDW" in another instance); or
- Option #2: the masked value should be deterministic (i.e., a single raw value is always replaced by the same masked value) for any given field but should not have the same character string length as the original unmasked value (e.g., "CDIC" can be masked as "UJ89LP4J" but if repeated in the same field, must be masked identically).

For greater clarity, masking refers to *substituting* original data with modified data. It is not acceptable to:

- Delete original data (i.e., change original data to null/void/blank);
- Use default values to mask data (e.g., "XXX" or "999"), unless instructed otherwise;
- Insert data into a field that was originally null/void/blank (i.e., where no data previously existed); and
- Mask data (or altering, in any way, from original) in fields that are not included in the *Masked Fields* table (see below).

#### **Masked Fields**
